Notes on this and the immediately prior, issue:

I had scheduled the Sends for 8am & 8:02am, respectively.

However, Substack did not let me pick the time zone. Substack Customer Service has been poor to antithetical, about fixing matters I've brought to their attention.

Apparently, it synched the time zone to GMT, putting the scheduled Send off by a wide margin. So hours later, when I found out it had not gone out, I then had to logon and manually tell it to go out (publish).

This is not a unique issue:

When I first started out trying to create a Substack newsletter, I sent out a test invitation first message to my self exclusively. But it did not go through. A viewbox message claimed they were, "*reviewing*" it to ensure all prospective recipients (all one of me) had agreed to sign up. Substack then failed to allow it through.

Yes, you got that right. Apparently, wanna-be subscribers had to agree in advance, learning of its existence via mental telepathy, as this was a test-run (thus to self only), for merely a FIRST message INVITATION to sign up. It took the involvement of one or more additional Substack writers, before that matter became corrected.

Subsequent matters, however, Substack persists in failing to correct.

After the message shown at the url below, Substack then completely wiped out ALL of my newsletter issues.
